First Time Application Fee: Non-refundable. Due when contract is signed and returned.	\$200.00
Annual Application Fee: Non-refundable. Due annually with annual update forms.	\$100.00
Late Fee: Annual update forms received less then 1 month prior to Anniversary Date.	\$150.00
<b>File/Maintenance Fee:</b> Administrative fee to cover application, OSP, and inspection report review. Non-refundable after signing of contract and/or annual update contract amendment.	See Chart below
<b>Certificate Fee:</b> Administrative fee to cover creation, printing, and shipping of certificate. Non-refundable after certificate is issued.	See Chart below
<b>Inspection Fee:</b> PJRFSI bills for the total cost of the inspection. Inspection fee includes inspector fee (preparation, planning, inspection, and report writing), inspector travel, and a 5% administrative cost on the inspector total fees. Non-refundable when the inspection is scheduled.	Varies.
Additional Site Inspection: if an additional site inspection is needed then PJRFSI charges \$200.00 per site plus inspector fees.	\$200.00 per site
<b>Expedited Processing:</b> Charged if application and OSP review will be required to be completed within 3 weeks of submission.	\$100.00
<b>Reinstatement fee (suspended certificate)</b> PJRFSI charges a reinstatement fee for clients that have been suspended from USDA NOP certification.	\$500.00
<b>PJRFSI Travel Fee</b> : PJRFSI charges a travel fee when inspectors are required to travel outside of Country of Origin.	Varies per country.
Additional Product, Label or Material Request: When a request to add an additional product(s), update or add a new label and/or add a new material is requested outside of the initial OSP review or annual update review then an hourly charge applies.	\$75.00 per hour
<b>Reapplication Fee:</b> A reapplicant that has been denied with PJRFSI is required to pay a remediation fee of \$300 with an additional hourly rate of \$75 per hour to review the applicants application.	\$300 with and additional \$75.00 per hour
<b>California Organic Registration</b> Clients located in California will incur a California Organic Registration fee of \$25.00 annually	\$25.00 per year
<b>UNNANOUNCED INSPECTIONS:</b> PJRFSI must conduct unannounced inspections certifier operations annually. Certified operators may undergo unannounced inspection incurring inspection fees. Typically, PJRFSI does not pass the inspection fees to the reserve the right to charge these costs to the client in cases of noncompliance, con investigations, and/or regulatory directives.	tion events without e client, but we
<b>SAMPLING</b> PJRFSI must conduct sampling for five percent of certifier operations annually for F accreditation. PJRFSI will not pass the accreditation samples fees for the five perce certificated operations to the client	

certificated operations to the client.

Certified operators may undergo sampling events without incurring sample fees. PJRFSI reserves the right to charge the sample fee costs to the client beyond the requirement of five percent of certified operations selected by PJRFSI, such as but not limited to: the cases of a noncompliance(s), complaints, investigations, and/or regulatory directives. Samples may include the collection and testing of soil; water; waste; seeds; plant tissue; and plant, animal, and processed products samples. **Non-refundable Fees**: Certification Fee is an annual fixed fee depending on your activities and organic sales. Certification Fee, Application Fee, and File/Maintenance Fee is non-refundable after signing of contract and/or annual update contract amendment. Inspection fees become non-refundable when the inspection is scheduled. A Withdraw, Surrender, or Denial at or after inspection you are liable for all certification and inspection costs and is not refundable. Certificate Fee is non-refundable after issuance of certificate.
