

### FSSC For Storage And Distribution

SSC 22000 can be applied to organizations that provide transport and storage services to the food, feed, and food/feed packaging industry. Certification is also apt for all food products, ingredients, and food packaging, and it covers transport and storage from any point within the supply chain. This includes by rail, air, water, and on land, such as:

- feed to farm
- farm to processor
- primary processor to manufacturer
- manufacturer to off-site warehouses
- warehouse to retail store or restaurant
- store or restaurant to end consumer

QFI is now using their new certification database to register clients, upload audits, close out nonconformities, and issue certificates. <u>SQF clients are required to register</u> their company in the new SQF database going forward.

RCGS has released the **GF401: Technical Briefing Document** to give a basic outline of the changes between Gluten-Free Certification Program Issue 3 and the BRCGS Global Standard Gluten-Free Issue 4 to support transitional preparation by certification bodies.

All audits to Issue 4 will commence as of August 5, 2024. Download the new GFCP Self Assessment Checklist to make sure you are prepared.
