HPSS Version Update 1.2

s of August 20th, GLOBALG.A.P. has published a version update of their Harmonized Produce Safety standard (HPSS). The update was precipitated by changes made by the United Fresh Produce Association to the Produce GAP Harmonization Initiative's Harmonized Standards (v.2.0) in September 2019. As a part of the GLOBALG.A.P. and United Fresh licensing agreement, the changes were then adopted and incorporated into the new revision of HPSS.

This new v1.2 of HPSS is obligatory as of November 20th, 2020 – therefore all audits or inspections conducted will now be on v1.2. The changes to HPSS in the new version include:



In the HPSS GR:

- Expansion of scope applicability (now including combinable crops)
- Clarification of the maintenance of competency (this now includes 5 inspections/audits against a GLOBALG.A.P. Standard)
- Adopted and included all relevant General Regulations v5.4-GFS in Parts I-III

In the HPSS CPCC:

- Several clarifications, explanations, or examples
- Moving control points to more relevant sections
- Reference to ISO 17025 for laboratory accreditation of analyses
- Verification of calibration methods available
- 8 new control points: Continuous improvement and food safety culture, site security, site response, response plan for leaks, risk assessment for post-harvest, packing materials inspection, hold, segregated, and release procedures for non-conforming product, and trash-handling (now included in both pre- and post-harvest)

Introducing **Produce Handling** Assurance (PHA) Standard Certification!

his newly-released standard is ✓ available to all qualified packing operations (including both open- and enclosed-shed environments) meeting the scope definition in North America, South America, Africa, Asia, and Australia. Incorporating FDA Food Safety Modernization Act (FSMA) requirements, PHA certification may be combined with Integrated Farm Assurance Standard for Fruit and Vegetables (IFA FV) audits to reduce redundancy and cost. With the integration of FSMA requirements, this certification can aid operations in identifying FSMA requirements that must be addressed at the farm level.

While not currently GFSI benchmarked, GLOBALG.A.P. has designed the standard with GFSI requirements in mind and anticipates benchmarking sometime in 2021.

Blended & Virtual Audits What Are The Options?

ith the ongoing coronavirus pandemic, many audits have been postponed or delayed – but what about audits that will have to go forward in a



virtual or semi-virtual, "blended" format? PJRFSI is here to help clarify - see the overviews below or reach out to us to determine what your organization will have to do for a successful audit.

BRCGS

Available only for announced, re-certification audits, BRCGS is allowing blended audits using a remote assessment via ICT (Information & Communication Technology) followed by an on-site audit. Adherent to IAF MD4:2018, smartphones, handheld devices, video cameras, etc. will be used to conduct a remote assessment. Once the remote audit via ICT has been properly executed, an on-site audit will be conducted within 28 days in order to ensure sufficient time for closure of non-conformities. If no compatible ICTs are available to complete the remote portion, the audit will revert to a fully onsite audit.

PrimusGFS

PrimusGFS is allowing the use of remote desk reviews in advance of an on-site audit in order to reduce audit duration and reduce exposure risks during the on-site portion. Certification Bodies are authorized to reject a desk review request depending on an organization's risk. These desk reviews are to be used only for announced or preassessment audits.

SQFI

SQFI is permitting parts of any SQF Food Safety and Quality code certification, recertification, and surveillance audits to be conducted using remote means. The amount of the audit conducted via ICT will depend upon the feasibility of using alternate methods to sufficiently collect information for the audit to be completed.

GLOBALG.A.P. has chosen to use the offsite module approach to mitigate coronavirus risk. 🔷

IFA Version 6 Update

s of December 2020, the GLOBALG.A.P. Board has decided to extend the revision phase of their Integrated Farm Assistance (IFA) Standard's new revision. The ongoing coronavirus pandemic has, unfortunately, hindered the participation of entities such as certification bodies and focus groups. Without the input and thorough consideration of these groups, the new version may not receive sufficient testing and input. By postponing the launch of IFA version 6 to April 2022, GLOBALG.A.P. hopes to better ensure that the new version will be fully tested and functional when it comes to market.

As for the timeline of release for IFA version 6, dates have changed somewhat. The launch of the new version was planned for September 2021, with obligatory implementation by September 2022. The timeline has been extended to the following dates:

- December 2020: the second draft will be available for consultation and the second round of the World Consultation Tour will begin
- May to June 2021: the field trials will take place alongside a third public consultation period
- April 2022: version 6 will be finalized and published with a one-year transition period
- April 2023: version 6 will become obligatory
