The Pennsylvania Department of Health sent an email to medical cannabis patients in the state today announcing a mandatory recall of hundreds of different vape cartridges:

Dear Medical Marijuana Patient/Caregiver,

The Department of Health is committed to ensuring that the Medical Marijuana Program is operating appropriately and effectively. As you know, the Department recently conducted a statewide review of all vaporized medical marijuana products containing added ingredients. After finishing this review, the Department has determined that certain vaporized medical marijuana products containing some added ingredients have not been approved for inhalation by the United States Food and Drug Administration (FDA).

Although some of these added ingredients may be considered safe in other non-inhaled products, patient safety is the top priority of the Medical Marijuana Program. Therefore, the Department has issued mandatory recall for all affected vaporized products. The lists of affected products and added ingredients are posted on our website at www.medicalmarijuana.pa.gov.



Cannabis Packaging

- ► Adherence to current packaging requirements
- Proper labeling
 - ► THC level of product
 - Name & address of production facility
 - Name of the infused product and ingredients by descending weight
 - Product cannot be a shape, color, package, or labeled to appeal to minors age 17 and under
 - Child-resistant packaging



Audit Types and Steps to Certification



Third Party Certification

- Provides audits and certifications outside of regulatory requirements
- Based on a recognized set of food safety standards such as GAP (Good Agricultural Practices) or HACCP (Hazard Analysis and Critical Control Points) and Good Manufacturing Practices(GMP) CFR 110







Code of Federal Regulations(CFR 110)

- Section 110 is the basis of most GMP programs and is the accepted base line for food and many States' Cannabis and Hemp Safety Programs
- There are other sections that get more specific relative to infant formula and other specific foods and packaging methods but that is not relative to our industry, for the most part.

Apple Butter


	Mold (AOAC 975.51)	Average of mold count is 12% or more
	Rodent filth (AOAC 945.76)	Average of 4 or more rodent hairs per 100 grams of apple butter
	Insects (AOAC 945.76)	Average of 5 or more whole or equivalent insects (not counting mites, aphids, thrips, or scale insects) per 100 grams of apple butter

DEFECT SOURCE: Mold - post harvest infection. Rodent hair - post harvest and/or processing contamination with animal hair. Whole or equivalent insects - preharvest, and/or post harvest and/or processing insect infestation, SIGNIFICANCE: Aesthetic

Chocolate and Chocolate Liquor

Insect filth (AOAC 965.38)	Average is 60 or more insect fragments per 100 grams when 6 100-gram subsamples are examined OR Any 1 subsample contains 90 or more insect fragments
Rodent filth (AOAC 965.38)	Average is 1 or more rodent hairs per 100 grams in 6 100-gram subsamples examined OR Any 1 subsample contains 3 or more rodent hairs
Shell (AOAC 968.10-970.23)	For chocolate liquor, if the shell is in excess of 2% calculated on the basis of alkali-free nibs

DEFECT SOURCE: Insect fragments - post harvest and/or processing insect infestation, Rodent hair - post harvest and/or processing contamination with animal hair or excreta, Shell - processing contamination
Significance: Aesthetic



Types of Food Safety Audits

- PJRFSI Cannabis Safety Standard
- Covers the 5 classic points of GMP:
- People, Premises, Processes, Products, and Procedures
- Can also be applied to GAP, and in conjunction with Organic

Reasons for Recalls

- Product test fails after distribution:
- Heavy metals, pesticides, etc,
- Actual plant material fails:
- ▶ Mold, fungus, pesticides
- ► Improper labeling, not child safe.




PJRFSI Cannabis cGMP Standard

- State-specific requirements also included


The 10 Golden Rules of GMP


- 1. Get the facility design right from the start
 - 2. Validate processes
- 3. Write good procedures and follow them
 - 4. Identify who does what
 - 5. Keep good records
 - 6.. Train and develop staff
 - 7. Practice good hygiene
 - 8. Maintain facilities and equipment
- 9. Build quality into the whole product lifecycle
 - 10. Perform regular audits

- ▶ Pre-assessment
- ▶ Review and implement Requirements
- ▶ Train Employees
- ▶ Internal Audit
- ▶ Implement Corrective Actions


